Given the geographic location, tourism and cultural and natural heritage are important pillars of the economy, but the crisis has significantly influenced other sectors as well. The panel will focus on how we can cooperate effectively in the post-pandemic reality. Panelists from different fields will provide their answers on how the cooperation in the region can contribute to minimizing the effects of the crisis as well as how to better integrate the twin digital and green transition into EUSAIR. The keynote speaker will reflect on the global trends and challenges for Europe until 2030 and the value of foresight in policy planning. The panelists will discuss how these challenges have been taken on board as the priorities of the new European Commission related to the twin transition in the EU. Has the crisis provided a fresh perspective on the existing challenges and how can we harness the disruption for good? What are the main elements of the legislative package and EU budget which will power the recovery process with investments in a green, digital and resilient Europe? How can cooperation contribute to a long-term transformation of our economies and to more resilient societies? How can macro-regional strategies help in delivering the green deal/agenda when at the same time the countries are faced with economic losses and societal disruptions? What initiatives can be scaled up through the macro-regional framework and how can governments, businesses and communities work together? How can cooperation in innovation help? How can digital solutions help? What are the essential aspects of the circular economy to support the green transition? How can citizens be better involved?

### Thematic Session: Blue Growth (Pillar I) - Improving Competitiveness of Fresh Water Aquaculture Production in Adriatic-Ionian Region

From a blue growth perspective, aquaculture constitutes a strategic sector for future development and holds great potential for countries and communities in the Adriaticlonian region. If managed and governed properly, it can provide multiple benefits in terms of food security, employment, and economic development while reducing the dependence on often overexploited wild fishery stocks. However, the growth of aquaculture production poses challenges for the overall sustainability of the sector in the long term and raises concerns from different points of view, such as: governance, spatial planning, economic and market issues, ecological and environmental concerns. In recent years, a number of activities have been undertaken to address these challenges in regional, national, and local level, especially in the marine aquaculture sector. On the other hand, freshwater aquaculture in Adriatic-Ionian Region, due to more or less traditional farming methods combined with a slow growth rate and high production costs, requires further innovative activities and the exchange of best practices to increase efficiency and competitiveness of the sector.

Competitiveness of the aquaculture sector nowadays is affected by a crisis caused by the pandemic of COVID-19. While the repercussions for the aquaculture sector are not yet well understood, it appears that liquidity will soon become an issue for many farmers. The session will be the occasion to present the specificity of aquaculture sectors in the Region, try to give answers on how to improve the sector's competitiveness -mainly through innovation and marketing, as well as how the pandemic has affected aquaculture in the Region and what perspective can be envisaged for the future.

12:30-13:40	Thematic session: Connecting the Region: Energy Networks (Pillar 2) – Energy Networks for a Green Adriatic-Ionian Region
	The Adriatic-Ionian Region should develop a collective ability to transform its energy system and economy towards a more sustainable path. Delivering reductions in greenhouse gas emissions to confront climate change is the challenge. The EUSAIR must be at the forefront of coordinated efforts by its participating countries to achieve environmentally sustainable solutions for the energy transition. Energy systems integration and the harmonised planning and operation of energy networks, new infrastructures as well as actions on energy consumption sectors are the pathway to a green Adriatic-Ionian Region. There are two prongs to this purpose. The first prong is expanding and interconnecting national power systems to create opportunities for large-scale deployment of low-carbon energy sources and grid digitalisation. The second prong is expanding and interconnecting natural gas systems to promote security and availability of natural gas supplies while exploiting opportunities offered by new projects, gas storage and counterflows towards an efficient trading hub as a key element in the energy transition.

14:30- 15:40	Thematic session: Connecting the Region: Transport (Pillar 2) - The impact of Covid-19 on Transport and Mobility in the Adriatic-Ionian Region: current impacts, views and perspectives for the future
	The COVID-19 emergency and the lockdowns of cities have had a strong impact the transport and mobility sector. Travel demand, in particular, registered unprecedented overall contraction, with some relevant differences by sector a segment: passengers transport has dramatically dropped by 90%-95% in the case medium and long-haul (intercity) transport; while, freight transport, though declini has maintained levels close to the pre-crisis ones, due to an increase in urban deliver and food and pharmaceutical freight distribution. In some cases, the pandemic been a stimulus for new transport solutions and for improving the performance of existing transport supply. The future is uncertain about when the pre-crisis dema levels would be resumed and in terms of what could be the impact on transport sup (investments, operators, travel behavior, etc).

All countries of the macro-region provide habitats for Europe's large carnivores, including the grey wolf, the Eurasian Lynx and the brown bear. These species require large habitats to sustain viable populations. Therefore, a joint management and the investment in the landscape infrastructure to support green/blue corridors is needed. The alignment of policies and approaches across the region will contribute to the effective management of shared natural resources. The discussion will focus on commitments and obligations under national legislation of each country, the EU nature protection acquis and the corresponding multilateral environmental agreements to showcase the delivery of essential ecosystem services in the Adriatic-Ionian Region.
