



# INFORMATION NOTICE PURSUANT TO EU REGULATION N.679/2016 - GENERAL REGULATION FOR THE PROTECTION OF PERSONAL DATA (GDPR)

This information notice, provided to interested parties pursuant to European Regulation no. 679/2016, governs the processing of personal data provided by you to the North Adriatic Sea port Authority in relation to your participation in the final conference of the INTESA Project (co-funded by Interreg Italy-Croatia Programme – ID 10045821).

#### Owner of the treatment of personal data and contact data - Art.13 co.1. lett. a)

#### Purpose of processing and legal basis - Art.13 co.1 lett.c)

The Data Controller processes the personal data you have communicated in the performance of tasks of relevant public interest - pursuant to Art. 6 co.1 lett. e) of the GDPR and Art. 2 sexies lett.bb) of Legislative Decree no. 196/2003 as amended by Legislative Decree no. 101/2018, and in particular:

- for the participation to the initiatives proposed by the North Adriatic sea Port Authority within the INTESA Project (co-funded by Interreg Italy-Croatia Programme – ID 10045821);
- to allow the audio/video recording and/or the photographic collections of the participants to the initiatives of the Project, realized both in presence and remotely, that will be able to be published on the web sites of the institutions participating to the Project, as well as, on social networks (among which Facebook, Youtube, Instagram, Twitter);
- for the production and dissemination of materials on physical and / or digital media, which can be disseminated before, during, after the events promoted within the Project and / or published on the website of the Project, as well as, on social networks (including Facebook, Youtube, Instagram, Twitter).

## Place and methods of treatment - Art. 13 co.2 lett. f) and Art. 29

Personal data, freely given, are treated exclusively in the national territory by the staff of the North Adriatic sea Port Authority, educated, trained and authorized to the lawful treatment of data, according to the principles of correctness, lawfulness, transparency, pertinence and not exceeding the purposes of collection and subsequent treatment.

All the minimum security and confidentiality measures aimed at preventing the loss of data, illicit or incorrect use or unauthorized access are reserved to the interested party.

It is not expected the use of automated processing or automated decision-making processes or aimed at profiling the person concerned.

#### Obligation to provide data - Art. 13 co.2 lett. e)

The provision of data for participation in the initiative is mandatory and the refusal to provide the same prevents participation in the initiatives proposed under the INTESA Project (co-funded by Interreg Italy-Croatia Programme – ID 10045821).

#### Scope of data communication - Recipients - Art.13 co.1 lett. e)

The data processed by the North Adriatic Sea Port Authority will be communicated to internal personnel authorized to process them.

## Type of data processed - Art. 4 n.1

The personal data being processed are those provided by filling out this form and fall into the category of identification and contact data.

## Transfer of data abroad - Art. 13 co.1 lett. f)

The data are not transferred to third countries outside the European Union.





# Period of conservation of personal data - Art.13 co.2 lett.a)

The data will be kept according to the deadlines provided for by the law, without prejudice to the archiving and storage obligations provided for by the regulations, by the Manual for the management of documents and document flows of the North Adriatic Sea Port Authority.

# Rights of the data subject - Chapter III of EU Regulation n.679/2016

As a data subject, you may request access to your personal data, for rectification, integration or even, in extreme cases, erasure or restriction of processing, or object to processing. You may also lodge a complaint with the national supervisory authority, the Guarantor for the protection of personal data, as provided for in art. 77 of EU Regulation n.679/2016.
